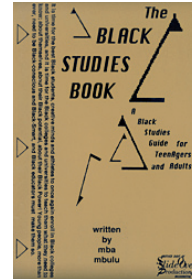
If a poor country like Cuba can provide free health care and free public school and university education, why can't a rich country like the US of A do likewise?

Why? Because the US allows big businesses to rip its citizens off, and US citizens are too intelligence challenged to realize they are being ripped off.

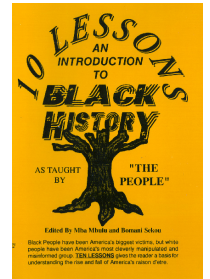
African Americans apparently have been made just as intelligence challenged as white Americans. Why else would African Americans be so stuck on white power America?
